In the Intro, Liz speaks about the word advocacy. Lucas thinks advocacy means, "speaking out for one's self to get the things you need". Lucas shares a story about his experience in the cafeteria. Some behaviors due to his disability kept him sitting at a separate table at lunch. Lucas had to speak up and advocate for himself so he could sit with other students. When his advocacy made a difference and he could sit with his fellow students, he says he felt, "proud". Sometimes people around us don't know how we feel unless we speak up.

Podcast Guest Victoria talks about her advocacy during her time in highschool when she had to continually request alternative test formats because bubble tests (scantrons) didn't work for her. Her ability to write was different than her classmates and she needed a different style of test to be successful.
